



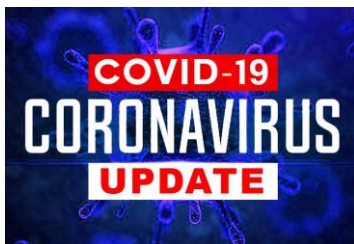

Coronavirus Disease 2019 (COVID-19) Update

Public Health - Dayton & Montgomery County, along with the Ohio Department of Health (ODH) and the Centers for Disease Control and Prevention (CDC), are closely monitoring and responding to the COVID-19 (coronavirus) global pandemic.

As of August 4, 2020, The United States reported **4,718,249** cases with **155,478** deaths. Ohio reported **95,106** cases with **3,570** deaths. Montgomery County reported **4,092** cases with **80** deaths.

On August 4, the following announcements were made during the Governor's press conference:

- DeWine discussed students going back to school in the fall. The Governor said things are uncertain, because the state hasn't dealt with anything like coronavirus in the last 100 years. "Schools and parents continue to work to make decisions on how to safely go back to school. I know there is frustration by the uncertainty. We cannot know what the next 3 weeks will bring, let alone the next 3 months, 6 months, or 9 months of school," DeWine said.
- Mercer County has the highest number of cases in the state per 100,000 residents with 230 cases per 100,000 since July 21, DeWine said.
- Doctors are now advising that kids in grades K-12 should wear masks, DeWine said.

- An additional order in relation to schools will be issued by the state today, DeWine said. The new order will require that students in grades K-12 wear masks at school. “This gives us the best shot to keep Ohio’s kids and educators safe and physically in school,” DeWine said.
- Lt. Gov. Jon Husted addressed the confusion about sports at schools. He said that non-contact sports have already been allowed to resume both practices and competitions. The state renewed an order on Aug. 1 regarding contact sports, but Husted cautioned that is not the return to play plan for the fall.
- Husted said the state is still working with the Ohio High School Athletic Association with a plan to return to play for football and other contact sports games. Husted said the new guidance could be issued in the coming days.
- Husted said the state has had conversations with both the Cleveland Browns and Cincinnati Bengals and are reviewing plans still regarding fans attending those games this fall.
- DeWine said the state continues to see a coronavirus spread problem because of informal gathering among families and friends. “We all have to remember that just because it is your family or your friends, they could still be carrying the virus and not know it,” DeWine said.
- DeWine said the state has been conducting an average of 23,000 coronavirus tests. The state is now entering into a multi-state purchasing agreement with Maryland, Louisiana, Massachusetts, Michigan and Virginia to expand the use of rapid point-of-care tests.

Updates from Public Health’s COVID-19 Situation Report:

It needs to be continually enforced that we are still in the middle of a pandemic. Enforce social distancing, hand-washing and the wearing of masks.

- Retesting of staff at nursing home facilities will be accomplished with assistance from the Ohio National Guard.
- The information line has moved from the 4th floor to the 2nd floor.
- Additional space is being identified and setup for contact tracing staff.
- Currently the county drop-site has a significant amount of PPE. Requests for PPE can be made through the following link:

- Public Health has issued recommendations on K-12 schools reopening.
- Public Health continues to meet weekly with local colleges and universities to discuss planning issues for the summer as well as the fall.

- Public Health continues to facilitate conference calls with congregate locations within the county.
- The Public Health COVID-19 informational phone line remains open Monday through Friday to answer general questions. The info line is 937-225-6217.
- ODH information line remains open, the number is 1-833-4-ASK-ODH and is open seven days a week.
- Public Health continues to monitor all sources (ODH, CDC, WHO, European Center for Disease and Prevention and Control (ECOC) for the latest information.
- Public Health will continue to share the situational report with other local health departments, Montgomery County Emergency Management, Greater Dayton Area Hospital Association and Dayton Metropolitan Medical Response System partners.

The hours for Public Health’s Specialty Clinic have been changed to 8:00 am to 12:00 pm (noon) Monday to Friday. The Clinic provides specialty services for Sexually Transmitted Diseases (STD), Tuberculosis (TB), and Refugee Health and is located in the Reibold Building at 117 S. Main St. in Dayton. This change will be in effect until further notice.

Public Health’s Immunization Clinic is open Monday - Friday 8:00 - 11:30 am and 12:30 - 4:30 pm. The full day schedule will allow us to get the students in for their back to school immunizations.

Air Pollution Advisory Name Change

RAPCA recently changed the name of its Air Pollution Advisories (APA) to Air Quality Alerts (AQA) in conjunction with the Miami Valley Regional Planning Commission. The name change was made to coordinate messaging with other area partners, including the National Weather Service, who were already using the term “Air Quality Alerts”.

RAPCA will issue Air Quality Alerts anytime air pollution levels are expected to be unhealthy for sensitive populations such as the elderly, children and anyone with respiratory diseases, which equates to a 101 or greater on the Air Quality Index (AQI) scale.

RAPCA has issued five Air Quality Alerts in 2020 and experienced three days where the AQI exceeded 100. Anyone interested in receiving air pollution forecasts via email or texts can sign up for U.S. EPA’s EnviroFlash service at <http://www.enviroflash.info>.

During NIAM, Public Health encourages you talk to your doctor, nurse, or other healthcare professional to ensure your family is up to date on recommended vaccines.

August is National Breastfeeding Awareness Month

Public Health is celebrating *Breastfeeding Awareness Month* in August. This year's theme "*Support Breastfeeding for a Healthier Planet*" focuses on the importance of supporting all members of a breastfeeding family, as well as working to advocate for breastfeeding supportive environments that contribute to healthier local communities.

The American Academy of Pediatrics and the World Health Organization recommend exclusive [breastfeeding](#) for the first six months of life and continued breastfeeding with the addition of appropriate solid food for the first year and beyond. Breastfeeding reduces child mortality and has health benefits that extend into adulthood. In addition, breastfeeding contributes to the health and well-being of mothers and reduces the risk of ovarian cancer, breast cancer, high blood pressure and Type 2 diabetes.

Only one in four infants is exclusively breastfed as recommended by the time they are six months old, and Black infants are 15% less likely to have ever been

breastfed than White infants. Public Health promotes the benefits of breastfeeding and provides support to nursing mothers and families. Montgomery County benefits from having healthier mothers, babies and children when breastfeeding is promoted, protected and supported.
