

**AGREEMENT FOR HOME HEALTH AIDE AND OCCUPATIONAL THERAPY SERVICES
BETWEEN THE PUBLIC HEALTH NURSING SERVICE OF DAYTON
AND THE PUBLIC HEALTH NURSING SERVICE OF MONTGOMERY COUNTY**

This contract made and concluded at Dayton, Ohio, by and between the Public Health Nursing Service of Dayton and the Public Health Nursing Service of Montgomery County.

WHEREAS, the Public Health Nursing Service of Montgomery County is in need of the services of a Home Health Aide and Occupational Therapist to provide services in Montgomery County, and

WHEREAS, the Public Health Nursing Service of Dayton is qualified and willing to provide such services as may be needed by the Public Health Nursing Service of Montgomery County.

NOW THEREFORE, it is hereby mutually understood and agreed as follows:

- (1) The Public Health Nursing Service of Dayton hereby agrees to provide Home Health Aide and Occupational Therapist services to persons within the Montgomery County Combined General Health District upon request of the Public Health Nursing Service of Montgomery County or their duly authorized representatives. Such services shall be rendered only in accordance with orders of the attending physician for any person within the health district for which services are requested.
- (2) The Public Health Nursing Service of Dayton shall provide such services under the general supervision of the Public

Health Nursing Service of Montgomery County or its duly authorized representatives and under the direction of the attending physician of the person to whom services are to be provided and only after acceptance of the person as a patient by the representatives of the Public Health Nursing Service of Montgomery County in accordance with section 405.1240, HIR-12 (9-68) "Regulations", as published by the U.S. Department of Health, Education and Welfare, Social Security Administration.

- (3) In addition to the provision of his services, the Public Health Nursing Service of Dayton shall, when requested by the Public Health Nursing Service of Montgomery County in staff meetings, recommending patient care policies, scheduling of visits, discussions for the purpose of planning and evaluating patient care in individual cases and planning when and how a plan of treatment is to be carried out. Said plan of treatment shall be in accordance with the plan of treatment as described in "Regulations" as published by the U.S. Department of Health, Education and Welfare, Social Security Administration, HIR-12 (9-68).
- (4) The Public Health Nursing Service of Dayton shall prepare progress notes and notes on observations on each patient and shall forward said notes to the representatives of the Public Health Nursing Service of Montgomery County

as soon as practical and advisable after the rendering of the service so they may be incorporated into the medical records.

- (5) The Montgomery County Combined General Health District shall reimburse the Public Health Nursing Service of Dayton for all services requested at the Board of Health current fee per visit and accept the same rate of reimbursement received from the Medicare Intermediary. The Montgomery County Combined General Health District will assume the responsibility of billing the Intermediary and will pay the Public Health Nursing Service of Dayton for services provided within 30 days upon reimbursement from the Intermediary and upon receipt of a bill.
- (6) This contract shall become effective on the 18th of June, 1970, and shall remain in full force and effect for a period of one year; provided, either party hereto may terminate this contract in thirty days by giving the other party hereto written notice by certified mail.

The parties hereto agree to review the provisions of this agreement prior to the termination of this agreement with the view of ascertaining whether this agreement or a revision hereof is necessary or advisable to provide adequate Home Health Aide and Occupational Therapist services in the health district.

The Chairman of the Board was authorized to enter into this contract by resolution duly adopted by the Board on the 18th day of June, 1970.
