Minimum Qualifications:

- A Bachelor of Science in Nursing OR an Associate degree in Nursing with two years relevant experience
- Current valid Licensure from State of Ohio to practice as a Registered Nurse
- Current valid Ohio driver's license and access to a motor vehicle (mileage is reimbursed at IRS rate)

Preferred Qualifications:

- Experience with a minimum of two years working with children/pediatrics and knowledge working with families on a continuum of care and knowledge of local resources.
- A Bachelor of Science in Nursing plus four years total experience (two of which are in Public Health) OR an Associate Degree in Nursing plus four years total experience in nursing (two of which are in Public Health)
- Excellent written/verbal communication skills and PC skills.
- Good understanding and knowledge of Third Party Medical Insurance and Medicaid Eligibility.

Responsibilities include but not limited to:

- Plan, develops community health-related programs including curriculum, Power Points, program material, educational pamphlets, and related literature; Identifies and visits Individuals who need public health services;
- Care coordination through outreach and home visits to perform health assessments of clients and educate them on various health topics; Refers clients to appropriate services available within the agency and community
- Data collection and assessing Healthy Mommy – Healthy Baby program outcomes; Evaluates the effectiveness of educational efforts; including periodic reporting
- Connect and refer women to applicable programs and services, provide follow-up to women via phone calls and other means as necessary to ensure her needs are met
- Care coordination through outreach of clients and educate them on Safe Sleep, smoking during pregnancy, breastfeeding, prenatal care, mental health(stress) sessions
- Address health, social, behavioral, case management, and environment risk factors for infant mortality
- Monitor the health care tasks the Community Health Worker are performing.
- Refers clients to appropriate services available within the agency and community groups, and schools to network and promote tobacco cessation and prevention
- Performing health screenings; recording patient progress regularly and developing a plan of care.
- May be required to play an active role in the event of a public health emergency, which may include changes in responsibilities and working hours
