- Supervises and evaluates performance of Disease Intervention Specialist staff; Coordinates with staff to develop
  goals and objectives of program; Conducts staff meetings, develop goals and objectives of programs; Recommend
  personnel actions.
- Develop and update STD/HIV policies and procedures as needed. Develop, review and compile STD/HIV information necessary for required federal state reports, and annual grant reports.
- Provide front line support during STD/HIV breakout investigations.
- Perform STD/HIV field investigation including blood draws when needed; Review orders, distribute appropriate informative and promotional materials.
