### **Supporting LGBTQ Youth Summit**

The LGBTQ Health Alliance presented [“Supporting LGBTQ Youth”](#) - a two-day training session for professionals who serve youth on November 4 & 5 at the Dayton Metro Library. Attendees received comprehensive LGBTQ youth cultural competence/humility training and connected with local LGBTQ youth-serving organizations that can be ongoing resources in the future.

The training is facilitated by the *Safe and Supported Program* from Lighthouse Youth and Family Services which offers an LGBTQ youth-centered approach. Areas of concentration include; relationship building, values clarification, school and family safety, sexual orientation education, gender identity, pronoun usage and other terminology. The summit also seeks to build relationships with partners for future advocacy and support.

The Summit was a collaborative effort between Public Health - Dayton & Montgomery County, Lighthouse Youth and Family Services, Dayton Children's Hospital, PFLAG Dayton, Daybreak Dayton, and Miami University's Dennis L. Carlson Sexuality Education Studies Center.



### **Lung Injuries Related to Vaping Continue to Rise (Update)**

The Centers for Disease Control and Prevention (CDC) and multiple states are investigating the occurrence of severe pulmonary disease among people who report vaping. CDC is referring to e-cigarette, or vaping product use associated lung injury as [EVALI](#).

Vaping products contain many substances and may include nicotine, tetrahydrocannabinol (THC), synthetic cannabinoids, or a combination of these. Currently, there are no known links to a specific type of product. As of Tuesday, October 29 there were 37 deaths and 1,888 cases reported across 49 states. State and local public health officials in Ohio have confirmed 47 cases of vaping-related severe pulmonary illness and are investigating an additional

36 reports of illness. There have been 2 cases reported in Montgomery County.

On September 30 the Ohio Department of Health (ODH) issued a Health Alert requiring health care providers or any individual having knowledge, to report to their local health department (LHD) by the end of the next business day, all suspected cases of severe pulmonary disease of unclear etiology with a history of vaping in the past 90 days.

Public Health widely disseminated the information to multiple community partners, including the Greater Dayton Area Hospital Association to forward to hospital Infection Control Practitioners and to physicians within the respective networks, urgent cares, school nurses and the federally qualified health centers.



### **Addiction Services Offering New Anger Management Group**

Public Health's [Addiction Services](#) will be offering an Anger Management Group beginning in November of 2019. Groups will be closed and offered in six-week cycles. The group will utilize an evidenced-based curriculum developed by SAMSHA. It will assist clients in understanding anger, its origins and how it manifests itself in their lives.

Skills that will be taught are:

- Conflict resolution
- Assertiveness skills
- Development of an anger control plan
- Emotional regulation
- Healthy stress reduction techniques

This group is free for current Addiction Services clients. The classes are designed for individuals who want to enhance their ability to manage their anger to improve their lives. Court-involved individuals may also be required to attend the classes to gain anger management skills.

Classes will be held at Addiction Services, located at 1 Elizabeth Place SE in Dayton on Tuesdays from 9am – 11am, beginning November 19, 2019. For more information contact Addiction Services at (937) 461-5223

## Ohio Environmental Health Association Presenters

Public Health Sanitarians along with Environmental Health Director, Jennifer Wentzel attended the [Ohio Environmental Health Association's](#) Southwest Conference on October 2 & 3 at Sinclair Community College. Ms. Wentzel was a keynote speaker, presenting on Public Health's response to multiple events in 2019, including the February 13 water main break and the Memorial Day tornadoes. She also presented in a breakout session along with Sanitarian Supervisor, Matthew Tyler on Environmental Health's tornado response.

These presentations focused on Public Health's role during an emergency event, including:

- Implementing the National Incident Command Structure
- Coordinating with community partners and state and local agencies
- Helping setup and support a family assistance center
- Engaging with businesses in the community to ensure safe food and water, along with proper debris management during emergency events.

The presentations concluded with Public Health's commitment to the long-term recovery of the region by working with the community and being at the forefront of emergency preparedness and response.



## RAPCA Asbestos Coordinator Receives Federal Award

[RAPCA](#) Asbestos Program Coordinator, Sarah Gessner, was awarded a **Coin Award**, which is a symbol of excellence, by the U.S. Attorney's Office, Southern District of Ohio for her work on the *U.S. vs Riazzi* investigation.

The case involved the renovation of an old steam generation plant located in downtown Dayton. John Riazzi worked with the City of Dayton to purchase the property for \$10 with plans to renovate the building and turn it into a banquet hall. Riazzi received \$90,000 from the City of Dayton to properly renovate the facility. As part of the renovation process, an asbestos survey was required to identify all asbestos containing material, so it could be properly remediated before renovations began.

The initial asbestos survey of the building did not include the roof that was suspected of containing asbestos and Mr. Riazzi hired two untrained "scrapers" to hastily remove the roofing material before the scheduled asbestos survey could be performed. In addition to removing the material without a proper survey, the scrapers removed the material without proper containment and improperly disposed of the asbestos containing roofing materials at their personal residence.

RAPCA provided the Ohio Attorney General's (AG) Office and U.S. EPA Criminal Investigation Division with the local investigation findings of the improper removal incident. Sarah's hard work and skillful investigation helped lead the criminal investigators with the Ohio AG's Office and U.S. EPA to the successful prosecution of local businessman John Riazzi for federal criminal violations of the Clean Air Act.



## COAT Selected for OIPP Promising Practice Award

The Community Overdose Action Team (COAT) recently received the **Promising Practice Award** from the [Ohio Injury Prevention Partnership](#) (OIPP). OIPP's mission is to prevent injuries in Ohio by promoting evidence-based interventions and collaborative partnerships. Priority areas for OIPP include falls among older adults, drug overdose, and child/youth injury.

The OIPP Promising Practice Award recognizes outstanding community-based interventions aimed at reducing the incidence of injury and violence in Ohio. It is their hope that through recognition of innovative and effective programs such as the COAT, that partners across the state will consider similar strategies in their injury prevention efforts.
